# **Museum Breaks Ground on Sawmill Building**

s December temperatures fell and the ground grew colder and harder, Paul Moore on his excavator was joined by team members. John Bartholomew, Reggie Chester, Rodney Frary, Bob Moulton and Mark Roberson. Paul and Doug Matthie had graded the area earlier. Construction of the Sawmill Building was underway. It was time to set the big 6X6 posts in concrete before ground conditions worsened. Long 6X6 beams were then erected across the posts. Diagonal knee braces were added to steady the load. During the first two months of the new year, Paul, Reg, and others assembled roof trusses inside the warmer Pavilion Building. Matt Morgan helped lift the new trusses with his boom truck to the top of the beams. Strapped together, they are ready for steel roofing (see photo on back page). The building is being constructed in the manner others were built during the 1920's, the age of the Lane sawmill the building will house. The building will have 1.800 square feet of work room to protect the mill and workers from inclement weather. The team's objective is to have the facility operating in time for the June Exhibition.

### **Election Results Announced**

ew officers and trustees were elected at the Annual Meeting of the members in February. Elected to one-year terms were Roger Austin, President; Al Garrand, Vice-President; Julie McGraw, Secretary; Chuck Goolden, Treasurer; and Dave Baker, Trustee. Elected to threeyear Trustee terms were Reg Chester, Mike Gillette, and Bob Marshall. John Castle, Wayne Day, and Jim Locy had been elected as Trustees in prior years and continue to serve. A week earlier, Irene Hargrave had been appointed by the Board to serve another year as Assistant Treasurer and Honorary Trustee. Leaving the Board after many years of great service were Grant Thesier, formerly Vice-President, and Paul Moore, formerly a Vice-President and then Trustee. Both were recognized for their contributions to the growth of the Museum.

### **Public Toilet Plans Progress**


Preliminary work on plans for the Public Toilet Facility continues with a conceptual design completed and basic location and layout determined. The 24 X 24 foot building will be located about 60 feet from the corner of the Pavilion Building and its temporary kitchen facilities. Drinking water will come from the same line. Grease trap effluent will also be captured by the new septic tank. Lo-flow toilets and waterless urinals will minimize water usage. Hand sinks, at least one shower, a kitchen sink, and hot and cold water are planned. The cost of materials is estimated to be approximately \$20,000, \$5,000 more than the \$15,000 raised to date. The plans will be sent out to contractors for quotes to examine the alternatives of doing the construction with members or with outside help. *⊅*

# 2010 Projects Will Keep Everyone Busy

ork is already underway on projects budgeted for 2010. The Sawmill Building is going up, engineering and design for the Public Toilet Facility is underway, and the cost of various construction methods for the Horse-Drawn Equipment Building is being studied. Conceptual designs have been presented for two small buildings that will be built to house a shoe and leather shop and a printing shop. We hope to complete upgrades to the electrical, mechanical, and body work on the Century Flyer amusement park train. Other projects include installation of a site-wide security system, site surveying, expansion of the electrical and phone grids, restoration and erection of the windmill and relocation of the Walker Granary. Exclusive of the Public Toilets and Horse-Drawn Equipment Building, about \$20,000 has been budgeted for the projects. These will be accomplished as funding and volunteer time are available. Volunteers are especially needed to lead and assist with the Public Toilet, Printing Shop, Century Flyer, and Security System projects. Anyone willing to lead one of these projects should contact Al Garrand, Julie McGraw, or Roger Austin as soon as possible. X

### **EXHIBITS TO OPEN WITH REGULAR SCHEDULE**

ork is already in progress at the new Collection Building and elsewhere on exhibits that will be opened to the public on a regular schedule in late May or early June. Mary Jean Chester and Shirley Dickinson are gathering items from the collection, making signs, and preparing illustrations to support the theme of **Technology & Invention Help Shape Life in the North Country**. There is much work to be done, and volunteers are needed to take responsibility for various sections of the exhibits. Mary Jean is working on a milking exhibit. Shirley is organizing a shoe and leather display. She is also working on a forest products display and needs 6-inch wide wood planks of various native wood species. Bob Marshall will prepare horse-drawn vehicles, and Bob Smith is cleaning and organizing early tools. Volunteers are still needed to organize other exhibits, prepare signs and explanations, or help with the many other chores needing attention. When open, hosts will be needed to guide guests through the exhibits. Ron and Sheila Day and Wayne and Mary Day are looking for others to join them in this important service.

## **Treasurer Reports Year of Progress**

t the Annual Meeting in February, Treasurer Chuck Goolden reported that the Museum was in sound condition at year's end with virtually no debt. With cash contributions and donations to the collection, the Museum's total equity is over \$700,000. Of that amount, \$94,000 in cash is temporarily restricted for use on construction projects, particularly the Horse-Drawn Equipment Building and the Public Toilet Facility. Fundraising exceeded expectations with the \$74,250 gift from the family of P.E. Merrill. Another \$32,000 from other members and friends brought the total to \$106,000. *Every gift counts.* The Exhibitions continue to be important sources of revenue, netting nearly \$13,000 to help cover increasing operating expenses. Sale of food, ice cream, attic treasures and auction items are important contributors. Insurance is now our single largest expense, totaling \$6,600 in 2009. This sum will continue to grow as construction projects continue. Hats off to everyone who helped make 2009 a financial success.

Moore Excavation and Construction Co. provided heavy equipment and operators for several projects.


Mort Backus and Sons loaned their tilt-bed truck to help haul items.



### HORSE-DRAWN EQUIP-MENT EXHIBIT BUILDING

The Horse-Drawn Equipment Exhibit Building Committee met in February to discuss possible building styles and methods of construction. The 2010 budget provides \$150,000 for construction of the facility though the actual cost is still uncertain. Donations now total \$76,950. Envisioned is a 4,000 square foot exhibit facility. The committee has considered styles including a two-story barn with shed extensions on opposite sides and a **T**-shaped building. The latter was recommended. It would have an 80 X 40 foot main section with a 40 X 20 foot entrance area

forming the base of the **T**. Timberframe construction with classic mortise and tennon joints was found too expensive for a building of this size. Conventional frame and post and beam construction methods are being investigated. The building will exhibit a wide variety of equipment used during the long period when horse power was supreme. Displays will show how horses were hitched and how the equipment functioned. Smaller conventional horse barns, carriage houses, and stables will be built as parts of the Late 1800's and WWI Farmsteads planned for the future. These will be located in the area surrounding our existing facilities. There is a small stable in the barn next to the Goolden-Mann farm house.

### **Museum Collection Grows Through Generosity of Members and Friends**

The collection grew in many ways during 2009. *PastPerfect* professional collection management software was purchased, and Collection Management Committee Co-Chairs Jim and Julie McGraw pulled together a backlog of donations. Julie took three courses in collection management. Documentation of virtually all collection items was completed. Much of the collection is housed in the new 2,400 square foot steel building completed last year. Thanks to the generosity of many members and friends, the Museum's collection grew by 85 items with an estimated value of over \$50,000. This brought the total number of items in the collection to 222 with an estimated value of nearly \$150,000. Some new items had been donated in 2008 but not recorded until 2009. ### **Audit Committee Reviews Financials**

The Audit Committee consisting of Trustees Wayne Day, Robert Marshall, and Chair, Julie McGraw reviewed the financial well being of the Museum with Treasurer, Chuck Goolden during February. Also present were Finance Committee Chair, Al Garrand and President, Roger Austin. Balance sheets, bank and brokerage statements, original invoices, financial statements, and tax returns were studied. Tests were performed to determine consistency among these items and accounts contained within accounting software. The Committee found the accounts and reports to be in good order. Invoices are being paid in a timely manner. Goolden and Assistant Treasurer, Irene Hargrave, were complimented for the high quality of their services.
